Dear National Fire Academy Student:

By now you should have received an email notification from the National Emergency Training Center (NETC) Admissions Office. This notification indicates your acceptance into the U.S. Fire Administration (USFA), National Fire Academy (NFA) "Emergency Medical Services: Incident Operations" (EMS:IO) course.

Congratulations on your acceptance into the USFA's/NFA's EMS:IO course.

This course offers you the opportunity to study incident command techniques for management of medium to large incidents involving multiple sick or injured patients. Topics covered include Emergency Medical Services (EMS) functions within incident command, resource management, interagency and mutual aid, sizeup and strategy, EMS operations in the mass casualty incident (MCI), preincident preparation, incident organization, and strategic command. Through several simulated incidents involving increasing patients totals, the course will provide ample opportunity for practicing effective implementation of the EMS components of the National Incident Management System Incident Command System.

The EMS:IO course contains simulation activities based in the fictional Central City, Liberty County, and State of Columbia. Links to the online reference and a quick reference to the emergency medical services and hospital resources available in these jurisdictions are attached; you should become familiar with this prior to your arrival in class. Throughout the exercises, you will assume roles in those organizations.

This class is a six-day class which starts on Sunday at 8 a.m. Class sessions will meet daily from 8 a.m. to 5 p.m., with evening classes possible. Travel arrangements should be made in accordance with instructions from Admissions and in the NETC Student Welcome Package.

Specialty Resources

- Columbia National Guard (including a Medical Battalion, Civil Support Team, and Medevac)
- Red Cross, Salvation Army
- Requests for special resources may be made through Liberty Comm (dispatch), which will process the request through the Liberty County EOC.

Air Ambulances

- 9 air ambulances in State of Columbia
- Lifeflight 1: Central City Hospital
 - 1 RN, 1 Paramedic, 1 pilot. Can transport 2 patients, depending on environmental conditions.
- Med Flight 1: Capital City Hospital
 - Crew of 1 MD, 1 RN, 1 pilot. Can transport 2 patients, depending on environmental conditions.
- Flight for Life: St. Dorothy’s Hospital, Green County
 - 1 MD, 1 RN, 1 pilot. Can transport 2 patients, depending on patient acuity. Flight time to Liberty County 20 minutes. Can provide pediatric specialist with notification.
- Other air ambulances in Columbia:
 - Porter, Brookville, Petropolis, Clifton, Zurich, Tower Beach
 - CBP medevac, Annville: State mutual aid agreement for southeast wilderness area of Columbia

Central City Fire Department

- First line companies (engines, aerials, squads) provide BLS level first response to high-acuity dispatches. Crew of 4 EMTs.
- CCFD operates MCI 125 at Liberty International Airport. MCI 125 has triage, treatment, and transport equipment for 200 patients.
